Pursuant to Reg 33(3) of Securities and Exchange Board of India (Listing Obligations & Disclosure Requirements) Regulations, 2015 as amended from time to time (hereinafter referred to as 'SEBI (LODR) Regulations, 2015'), a listed entity is required to submit quarterly and year-to-date standalone financial results to the stock exchange with 45 days of end of each quarter, other than last quarter.

Further, pursuant to Reg 33(5) of SEBI (LODR) Regulations, 2015, any reference to 'quarterly/quarter' in case of entities which has listed its specified securities on SME Exchange shall be read as 'half-yearly/half year' and the requirement of submitting 'year-to-date' financial results shall not be applicable for a listed entity which has listed their specified securities on SME Exchange.
